AUCTION RULES:

- All dealers must be licensed by their state, and registered at this auction before doing business.
 Dealers should try to register in advance of sale day to expedite registration.
- Wichita's Auto Auction will issue bidder badges which will be used for admittance and all transactions.
- All units purchased must be test derived and paid for by the end of the business day.
- Buyer must pay for vehicles the day of dale. Checks will be held until title comes in. a single check written for multiple vehicles will be deposited that day.
- o All titles submitted by seller must be in seller's company name.
- o All transactions must clear through the office.
- o No vehicle will be offered for sale that has an altered serial plate.
- Once a vehicle is registered it cannot be removed from the auction unless it has been offered for sale across the block.
- Buyer is responsible for verifying serial number, model, year, and mileage reading on all
 purchases before leaving sale. Seller is responsible to insure a vehicle is properly offered for sale
 at the block. The auction will not be responsible for administrative errors.
- It is the seller's obligation to correct any errors made by the auction as to be announced "conditions". It is the buyer's obligation to watch lights and listen to announced "conditions".
- The auction does not guarantee the year of any foreign car, house trailer, motor home, boat, boat motor, antique, dune buggy, or motorcycle. Satisfy yourself before settlement, as the auction will not become involved in any subsequent dispute.
- All cars must have a gate pass before leaving the premises.
- o "IF" sales are binding on the buyer until end of sale of the day. After this time period "IF" sales may be turned down for any reason.
- "OUTSIDE SALES" The auction will not become involved in any arbitration procedures or be responsible for any defects on units sold outside of the sale.
- The auction does not guarantee any warranty books or plates.
- Frame damage or frame damage repair must be announced at yellow light.
- No foreign titles accepted
- The auction reserves the right to void any transactions.
- The action will require a seller to take back any vehicle with a documented odometer roll-back problem.
- Cars are left on the auction premises at owner's request and risk. The auction shall not be held responsible for loss of damage, even though the keys and car may be place in the auction's custody for services which are made available to customers on these terms.
- Seller will be responsible for all charges (Buyer and Seller fees) if he/she knowingly misrepresents the car.



AUCTION RULES CONTINUED

LIGHT SYSTEM

Green Light – "Ride and Drive" – subject to all arbitration

Yellow Light – "Announced Exceptions" – Selling dealer must announce exceptions to the vehicle. All arbitration rules apply exempt the "announced exceptions".

Red Light – "As is" – sold with no arbitration except for announced frame damage, odometer problems, or non function air bags.

ARBITRATION POLICY

Subject to Arbitration-Day of Sale Only

- Frame damage or frame repairs must be announced. Frame damage or frame repair (not including frame damage resulting from normal use: scratches, scrapes, jack or lift marks, not resulting from an accident) must be reported to the auction within 3 days after purchase.
- Air Bags Deployed Day of Sale Only No arbitration for Air Bag Light
- Drive trains on front wheel drive and four wheel drive.
- Any arbitration price adjustment eliminates arbitration for further mechanical defects.
- No arbitration on the following: Power accessories computer control units, radios stereo systems, cruise control, front ends, back lash, convertible tops, CV joints, air conditioning, or brake wear.
- Any units unsafe to drive is rejectable
- The auction will not be responsible for transportation or other expense on a returned vehicle
- Motor Transmission Rear End Noise
- Speedometer and odometer not working Day of sale ONLY
- Cam Phasers on all Ford F Series.
- No arbitration Differential Noise on Chrysler Products.
- No arbitration Lifter Noise
- No arbitration Blow By or Oil Leaks on vehicles over 30,000



ODOMETER POLICY

Sellers must announce from auction block the following:

- If odometer is not working properly
- If he/she has any knowledge that mileage on vehicle is different than mileage on odometer (not actual miles).
- Mileage in excess of mechanical limits
- Broken odometers, not actual miles, and mileage in excess on mechanical limits are specific
 conditions, and must be announced as separate conditions at the time of the sale as the
 condition warrants.
- Odometer readings must be in mileage, not kilometers
- Vehicles ten years or older mileage is EXEMPT. The auction will not become involved in mileage disputes on exempt vehicles
